Call to Order

Chairman called workshop to order.

Workshop - Road Issues

Public Works Director, Mr. Mark Deatcher, updated Board on road issues:

Mr. Deatcher requested funds in the amount of \$1,071.98 from contingency fund to install emergency light kit on his work truck.

Letter of Agreement for Glenn Walker

Letter of Agreement was provided for Board review regarding beaver control problems being handled by Glenn Walker. The agreement is between Board and Sheriff authorizing Mr. Walker to have a .22 rifle and pistol in his work truck as he retrieves beavers. Copy of letter will be forwarded to Department of Natural Resources. Mr. Glenn Walker, Road Foreman, has completed necessary course, Controlling Beaver Problems for County Employees and Others, through Department of Natural Resources. The cost is approximately \$1,000.00 for supplies; all items other than the deep freezer have been purchased for the year. Beavers will be stored in freezer; and shipped to Lowndes County to burn.

Commercial Air Compressor for Maintenance Shop

Commercial air compressor is completely inoperative; the shop is using a backup. Mr. Deatcher is looking into prices for a new one, as this one is non-repairable. He thinks cost will be approximately \$3,500.00.

Motor Grader Transmission

Problems continue with repair of motor grader transmission, Yancey cannot repair it. Mr. Deatcher is looking into purchasing a used rebuilt transmission for approximately \$11,000.00. Board authorized Mr. Deatcher to seek bids from three companies.

Mt. Carmel Church Road

Property owners will not give up right-of-way.

Rolling Hill Road

Mr. Lawson requested placing this road on the list for upgrade.

Dry Lake Road

Mr. Wingate reported a section of Dry Lake Road is deteriorating; and needs immediate repair.

Grooverville Road

Mr. Maxwell requested County Engineer go back and resubmit Grooverville Road to DOT.

Jackson Road and Campground Church Road

Mr. Lawson requested adding Jackson and Campground Road to improvement list.

Appearances

a) Jerry Miller – Approval of Firing Range

Previously the Sheriff requested Board approval to use Brooks County Inert Landfill as a firing range for his department. Mr. Miller appeared to request an update on the approval. County Administrator provided copy of letter from DNR stating the inert landfills are not subject to current environmental monitoring regulations due to the types of wastes disposed. However, the Construction Activity Prohibition on Abandoned Landfills Act of 1988 directs authority for future use of the site to the building and zoning departments of either City or County government where landfill is located. On motion by Mr. Lawson, seconded by Mr. Wingate, Board unanimously approved use of inert landfill as firing range, but building/construction can be place on site. County Attorney commented an application may need to be prepared through Zoning Office.

b) Richard Goodman

Mr. Goodman appeared to ask Board to include in his personnel file the findings from Department of Labor appeal hearing decision stating allegations were incorrect in connection with his termination as Jail Administrator. On motion by Mr. Maxwell, seconded by Mr. Cody, Board unanimously approve Mr. Goodman's request to include in his personnel file and record in minutes the letter from Department of Labor appeal hearing decision that he did not violate policies and there was no first hand testimony of the allegations. Vote was unanimous.

c) Johnny Whiddon – Employee Tier System

Mr. Whiddon appeared to inform Board of updates with Extension Office. During past two years he stated funds have been reduced by over 20%; which has resulted in loss of 90 Extension agents in Georgia. In October plan was put in place to place each county within Tier System which is based on population, demographics, agriculture, urban and

non-urban, Extension support, etc. Brooks County was placed in a Tier 4, which says we will have only one agent. Mr. Whiddon stated he has been told he will lose Ag Agent, Garvie Nichols, in the near future. He asked Board to consider sending letter and making calls to Legislators and Extension leadership to try and save some of the funding will otherwise lose.

d) Carl White - Snow Road Closure

Mr. White appeared to discuss closure of Snow Road and possible dangerous traffic hazard being created for citizens/residents.

Destination Brooks Tourist Initiative - Monthly Update

Ms. Lauren Basford appeared to provide update. She stated Destination Brooks, The Quitman-Brooks County Tourism Project plans to focus on three goals in new year: creating a signature event to attract visitors to our County; starting a farmers market to highlight our local farms and pursuing the Certified Local Government designation which will help preserve our historic buildings. They have also obtained their non-profit organization status.
